

# **Executive Summary**

AQ Technology Partners LLC introduces **AQTP**, an ERC-20 utility token powering a next-generation financial, advisory, and blockchain-based ecosystem.

Our mission is to deliver **secure**, **transparent**, **and utility-driven digital assets** that provide real-world value for investors, businesses, and ecosystem participants.

### 1. Blockchain Layer — Ethereum (ERC-20)

Ethereum was selected because it remains the most stable and globally trusted environment for tokenized utility ecosystems.

### 2. Smart Contract Architecture
